### **Opportunity**

ADAMS Center recognizes the devastating impact of the ongoing conflict in Palestine, which has resulted in widespread suffering, displacement, and a dire humanitarian crisis. Millions are in urgent need of food, shelter, and medical assistance. In this critical time, we seek collaboration with local and national nonprofit organizations to ensure that families in need receive essential food and other necessities for self-support. Together, we can help alleviate the suffering of those in Palestine.

Proposals can include programming such as the following, but are not limited to:

- Humanitarian Relief: Provide food, clean water, medical supplies, and shelter to those in urgent need.
- Healthcare Access: Ensure access to medical services, including emergency care and psychological support for trauma victims.
- Livelihood Support: Assist affected individuals in rebuilding their livelihoods through skills training and financial aid.

Activities must take place within 12 months following receipt of the grant.

ADAMS Center anticipates entering partnership agreements, with funds disbursed upon approval. A final report will be required upon project completion, as a matter of good faith.

### **Eligibility**

The eligible applicant for this opportunity announcement is limited to registered IRS 501(c)(3) nonprofit organizations.

Funding decisions will be based on the needs and goals of the project proposal.
